Since 2008, government stopped the digging of stone and sand, this continued esaki a kontinuá te 2010 ora ku e servisionan kompetente a konsehá gobièrnu pa stòp until 2010 when competent agencies advised the government to definitively stop this activity. definitivamente ku e aktividat aki.](#)
